(predecessor in interest to FTI Consulting Inc.) in favor of Administrative Agent, and a Notice of Grant of Security Interest in Trademarks dated as of September 29, 2006 by Attenex Corporation in favor of in favor of Administrative Agent, the Grantors granted a continuing security interest in and continuing lien upon, the trademark registrations and trademark applications set forth on Schedule A attached hereto to the Administrative Agent (the "Trademarks");

WHEREAS, the Notices of Grant of Security Interest in Trademarks were recorded with the United States Patent and Trademark Office on October 21, 2002 at Reel 2605/Frame 0593; June 27, 2006 at Reel 3339/Frame 0820 and Reel 3339/Frame 0877; January 23, 2008 at Reel 3702/Frame 0073 and October 1, 2008 at Reel 3862/Frame 0005.

WHEREAS, the Administrative Agent has agreed to terminate and release its continuing security interest in the Trademarks.


