TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of October 13, 2010 by LANDSBANKI ÍSLANDS HF (“**Grantee**”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Assignment (as defined below).

W I T N E S S E T H:

WHEREAS, Grantee and PROMENS USA, INC., a Delaware corporation and successor by merger with Elkhart Plastics, Inc., an Indiana corporation (“**Grantor**”), are parties to a Trademark Security Agreement dated as of April 25, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the “**Assignment**”), pursuant to which Grantor granted a security interest to Grantee in certain trademarks (“**Trademarks**”) and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Grantee, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office (“**USPTO**”) on May 30, 2006, at Reel 3319, Frame 0202; and

WHEREAS, Grantor has requested that Grantee release its security interest in the trademark listed on Schedule 1 (the “**Trademark**”) and Trademark Rights (as defined below) and reassign the same to the Grantor.


NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “**Trademark Rights**”):
 - a. the Trademark together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, the Trademark; and
 - b. all products and proceeds of the foregoing, including without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of the Trademark, or (ii) injury to the goodwill associated with the Trademark.
2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, all of Grantee’s right, title and interest in and to the Trademark and the Trademark Rights.
3. Grantee authorizes and requests the USPTO to record this Release against the Trademark, as applicable.
