NOW, THEREFORE, in consideration of the terms and conditions provided in the aforementioned Purchase and Sale Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign, sell, transfer and set over to Assignee, its successors and assigns, all rights, title, and interest in and to the **Marks**, together with the goodwill of the business symbolized by said **Marks**, in the United States, its territories and possessions, and all foreign countries throughout the world, as well as all rights of action and recovery for past, present, and future infringements thereof for the full term and all subsequent terms of the registrations as fully and entirely as the same would have been held and enjoyed by the Assignor had this Assignment not been made. This assignment is made free and clear of any liens and encumbrances.


