The right to file foreign trademark applications on said trademark in its own name, wherever such right may be legally exercised, including the right to claim the benefits of the International Convention for such applications.



Cooperation to the best of our ability in the execution of all lawful documents, reasonably necessary to secure the rights of Assignee in the trademark.

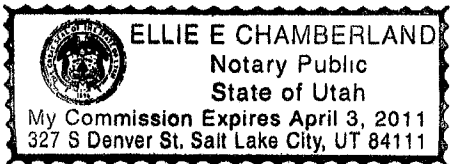
