TRADEMARK ASSIGNMENT

This Trademark Assignment (hereinafter referred to as the "Assignment"), dated as of February 4, 2010, is by and among Albion International, Inc. a Utah corporation with offices located at 101 North Main Street, Clearfield, Utah 84015 (hereinafter referred to as "Assignor"), and Novus International, Inc., a Delaware corporation with offices at 20 Research Park Drive, St. Charles, Missouri 63304 (hereinafter referred to as "Assignee").

RECITALS

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement, dated as of December 9, 2009 (the "Purchase Agreement"), pursuant to which Assignor has agreed to contribute, sell, grant, convey, transfer and assign to Assignee and Assignee has agreed to purchase from Assignor the Acquired Assets (as defined in the Purchase Agreement), which include the trademarks identified in Exhibit A (collectively, the "Marks");

WHEREAS, nothing in this Assignment shall modify or otherwise affect any provision of the Purchase Agreement or affect the rights of the parties under the Purchase Agreement. In the event of any conflict between the provisions of this Assignment and the provisions of the Purchase Agreement, the provisions of the Purchase Agreement shall govern and control; and

WHEREAS, in accordance with the Purchase Agreement, Assignor has designated its rights in acquiring and maintaining the Marks to Assignee; and

WHEREAS, Assignor and Assignee wish to enter into this Assignment for the sole purpose of confirming and memorializing the terms of the Purchase Agreement, and making said terms of record in the office of any trademark authority worldwide, including state trademark authorities, the United States Patent and Trademark Office, and the office of any applicable foreign patent authority.

NOW, THEREFORE, for good and valuable consideration by Assignor to Assignee in hand paid, receipt of all of which is hereby acknowledged, Assignor has agreed to and does hereby sell, assign, and transfer unto Assignee, its successors and assigns, all of Assignor's right, title, and interest in and to the trademarks listed in Exhibit A, together with any and all of the goodwill of the business symbolized by and associated with said trademarks, and all past, present and future income, royalties, fees, damages, and payments now or hereafter due or payable in respect thereto, and in and to any and all past, present and future causes of action (either in law or in equity), and the right to enforce any rights and file any causes of action, including the right to recover damages, for any past, present, or future infringement or misappropriation of the trademarks.

TO BE HELD AND ENJOYED by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this sale and assignment not been made.

AND Assignor hereby agrees to execute, acknowledge and deliver any and all documents as Assignee, in its discretion, deems desirable or necessary to make a record with any and all government agencies, authorities, courts, tribunals, or third parties, of the fact that Assignee owns all right, title and interest in and to the Marks, and any and all goodwill associated therewith, and that Assignor no longer has any right, title or interest, of any kind or nature, in or to the Marks.

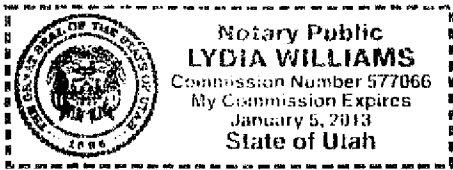
