TRADEMARK ASSIGNMENT

WHEREAS, **Cardinal Clothes Inc.**, a Canadian corporation (hereinafter called "ASSIGNOR") was the owner of and used the trademark set forth on the attached Schedule A, (the "Trademark") registered in the United States Patent and Trademark Office;

WHEREAS, Michael Ray, an individual residing in Westmont, Quebec, Canada ("Assignee"), as assignee of Jebco International Corporation, a corporation which held a security interest in the Trademark, had by notice dated dated March 5, 2010, demanded payment of the sum of \$102,861.84 from Assignor;

WHEREAS, Assignor failed to pay the demanded sum and by order dated July 19, 2010, the Superior Court, Province of Quebec, District of Montreal directed Assignor to surrender the Trademark and declared Assignee to have valid title of ownership with respect to the Trademark ("Order"); and

WHEREAS, as the owner of the Trademark pursuant to the terms of the Order, ASSIGNEE is desirous of acquiring all right, title and interest in and to the Trademark, in the United States, based upon the Order.

NOW, THEREFORE, in consideration of \$10.00 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR by these presents does sell, assign and transfer unto ASSIGNEE, its successors and assigns, all right, title and interest in and to the Trademark, together with the goodwill connected with the use of and symbolized by the Trademark. ASSIGNOR hereby transfers and assigns the ongoing and existing businesses associated with the Trademark and the goods and services related thereto.
