ARTICLE 1

Par les présentes, le CEDANT confirme qu'il a cédé les DROITS, incluant mais non limitativement, l'ensemble des droits, titres et intérêts, relatifs à toute continuation, continuation-in-part, division, ainsi que ceux relatifs aux brevets renouvelés, étendus, redéposés, redélivrés ou réexaminés sur la base des BREVETS, au CESSIONNAIRE par ACCORD DE CESSION signé le 14 avril 2010.

The ASSIGNOR assigned all rights, titles and interests in and to the RIGHTS (the PATENTS, the DESIGNS, and the TRADEMARKS) to the ASSIGNEE by an assignment deed signed by ASSIGNOR and ASSIGNEE on April 14, 2010, (hereinafter the "ASSIGNMENT DEED").

The ASSIGNOR and the ASSIGNEE have decided jointly to draw up the CONFIRMATORY ASSIGNMENT DEED for recording purposes only on any patent, design or trademark offices, throughout the world.

IT HAS BEEN AGREED AS FOLLOWS

ARTICLE 1

Hereby, the ASSIGNOR confirms that it assigned the RIGHTS, including but not limited to the entire rights, title and interest in and to all continuations, continuations in-part, divisions, renewals, extensions and reissues of any of the PATENTS to the ASSIGNEE, by the ASSIGNMENT DEED, signed on April 14, 2010.

Consequently, the ASSIGNEE (i) may file patent, trademark and design applications, in any country, in its own name and may also claim priority right, of any such patent applications, in its own name, (ii) is appointed as a beneficiary to the ASSIGNOR's rights and a party to the ASSIGNOR's actions each in connection with the RIGHTS, (iii) has full ability to exploit and dispose of the RIGHTS as something belonging to the ASSIGNEE, and (iv) to start and/or enforce and/or proceed with any action in connection with the RIGHTS, more particularly in infringement cases and/or to seek compensation for damages suffered even for infringement prior to the EFFECTIVE DATE of the ASSIGNMENT DEED, in the sole name of the ASSIGNEE, its successors and assigns.

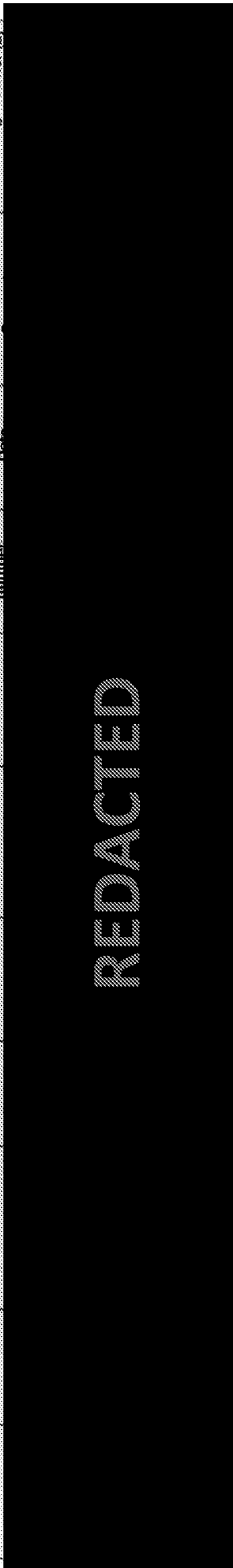

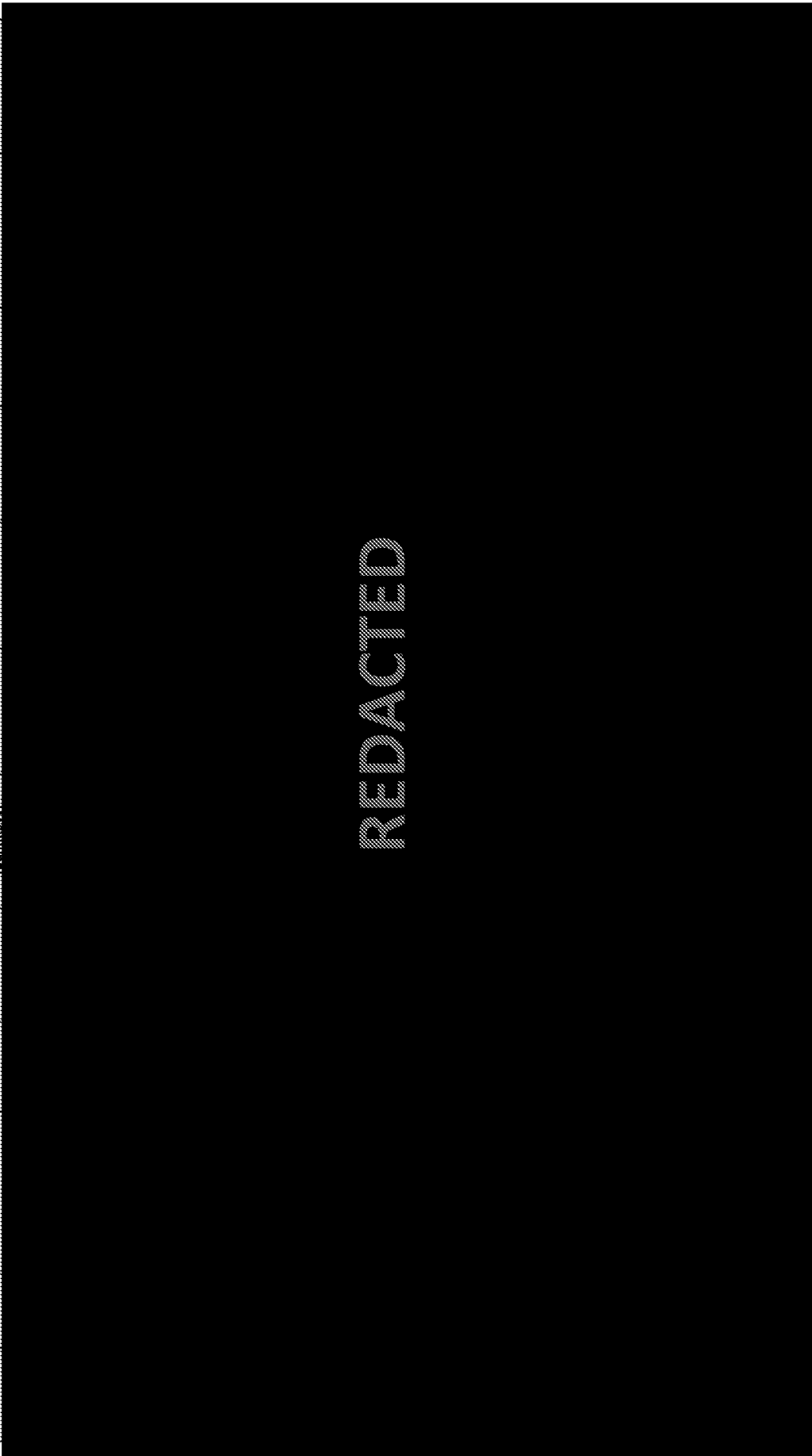

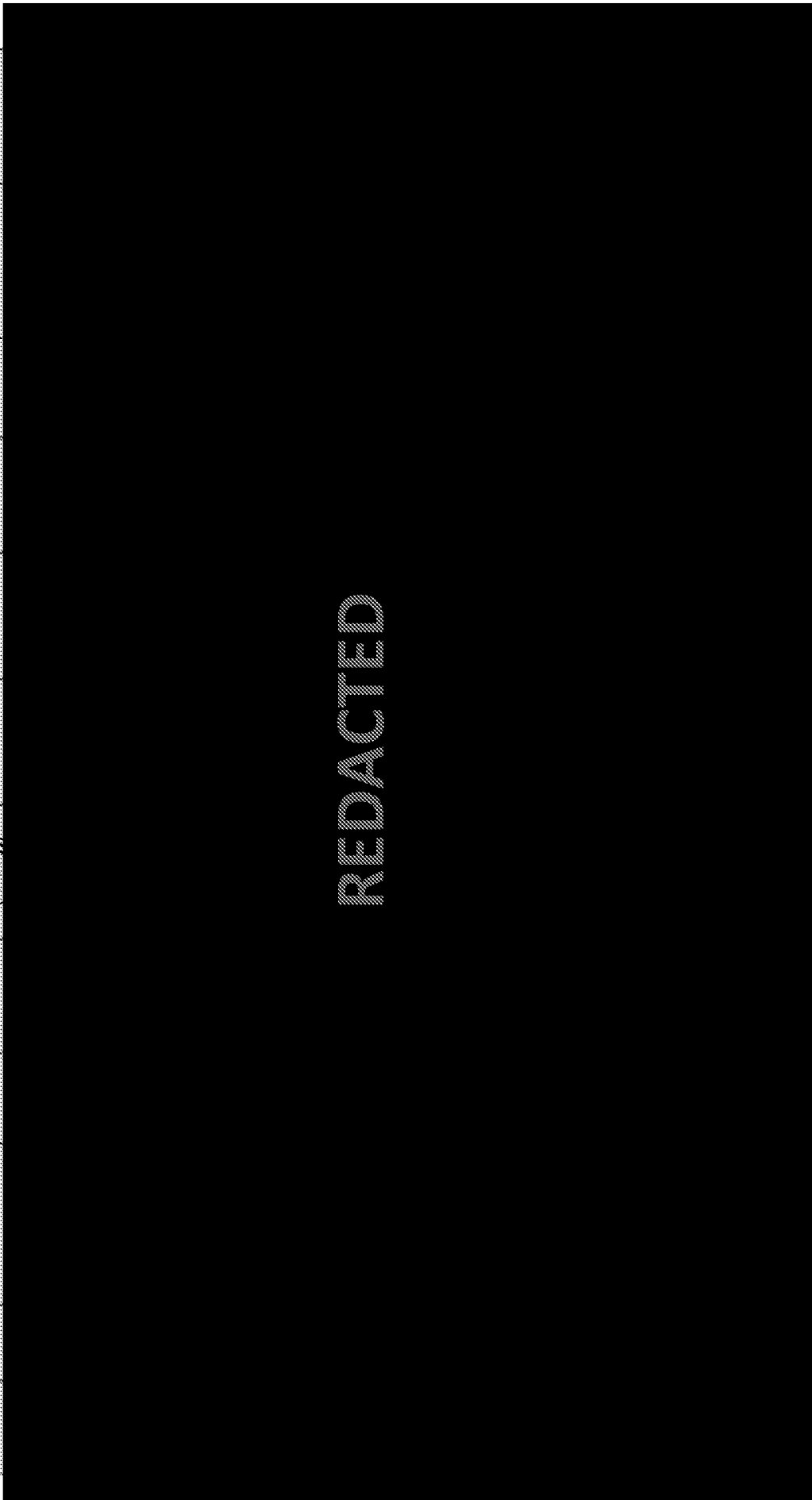
