## TRADEMARK ASSIGNMENT



Assignor agrees that it shall, without additional compensation, execute and deliver further instruments of conveyance, transfer and assignment as reasonably requested by Assignee, its successors, or assigns; reasonably cooperate and assist in providing information for making and completing regulatory and other filings; and take other similar actions as Assignee may reasonably require to effectively assign, convey and transfer the Mark, its associated goodwill, and all rights therein to Assignee.
