**ASSIGNMENT AND RELEASE OF
COLLATERAL ASSIGNMENT, PATENT MORTGAGE AND SECURITY AGREEMENT**

WHEREAS, pursuant to that certain Collateral Assignment, Patent Mortgage and Security Agreement (the "Security Agreement") dated as of November 17, 2009, made by GYNESONICS, INC. ("Debtor"), in favor of LIGHTHOUSE CAPITAL PARTNERS VI, L.P. WHEREAS, Lender desires to release its security interest in the Collateral and terminate the Security Agreement.


