RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, the Grantor has paid all of its outstanding indebtedness to the Agent secured by the Intellectual Property Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates the Intellectual Property Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all collateral pledge, grant, assignment, lien on and security interests it has in and to the Intellectual Property Collateral.

If and to the extent the Agent has acquired any right, title or interest in, or to any of the Intellectual Property Collateral, it hereby assigns and transfers such rights, title or interest to the Grantor without any representations, warranties or recourse of any kind whatsoever.

The Agent shall take all further actions, and provide to the Grantor and each of its respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
