

WHEREAS, this corporation lawfully owns 100% of the outstanding stock of Turblex, Inc., a corporation organized and existing under the laws of the State of Missouri, and

WHEREAS, this corporation desires to merge into itself the said Turblex, Inc., and to be possessed of all the estate, property, rights, privileges and franchises of said corporation, and the board deems it advisable.

NOW, THEREFORE, BE IT RESOLVED, that effective as of 12:01 AM, Eastern Standard Time, on October 1, 2010, this corporation merge into itself the said Turblex, Inc., and assume all of its liabilities and obligations, and

FURTHER RESOLVED, that the officers of this corporation be, and they hereby are directed to make and execute a certificate of ownership setting forth a copy of the resolutions to merge the said Turblex, Inc. and assume its liabilities and obligations, and the date of adoption and effectiveness thereof, and to file the same in the office of the Secretary of State of Delaware, and a certified copy thereof in the office of the Recorder of Deeds of New Castle County; and

FURTHER RESOLVED, that the officers of this corporation be and they hereby are authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware, which may be in any way necessary or proper to effect said merger.
