AND the Assignor finally declares that any prior use of the Trademarks by it or by any of its predecessors in title enures to the exclusive benefit of the Assignee.

This Agreement shall be binding upon the parties, their successors and/or assigns, and all others acting by, through, with or under their direction and all those in privity therewith.

This Agreement is governed by, and shall be construed and interpreted in accordance with the laws of Quebec and the federal laws of Canada, applicable therein.
