TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT, dated as of October 19, 2010, (as amended, restated or otherwise modified, the "Trademark Security Agreement") is by and among DINEEQUITY, INC., a Delaware corporation located at 450 South Brand Boulevard, Glendale, California 91203-2306 ("DineEquity"), IHOP IP, LLC, a Delaware limited liability company located at c/o International House of Pancakes, LLC, 450 South Brand Boulevard, Glendale, California 91203-2306 ("IHOP"), APPLEBEE'S IP LLC, a Delaware limited liability company, located at c/o Applebee's International, Inc., 4551 West 107th Street, Overland Park, Kansas 66207 ("Applebee's") and, together with DineEquity and IHOP, the "Grantors", and BARCLAYS BANK PLC, as administrative agent for the parties defined as "Lenders" under the Credit Agreement referred to below (in such capacity, together with its successors in such capacity, the "Administrative Agent").

WHEREAS, DineEquity is a party to a Credit Agreement dated as of October 8, 2010 (as modified and supplemented and in effect from time to time, the "Credit Agreement"), providing, subject to the terms and conditions thereof, for extensions of credit (by means of loans and letters of credit) to be made by such Lenders to DineEquity. In addition, DineEquity may from time to time be obligated to various of said Lenders (or their affiliates) in respect of one or more Secured Hedge Agreements and Secured Cash Management Agreements under and as defined in the Credit Agreement;

WHEREAS, to induce such Lenders to enter into the Credit Agreement and to extend credit thereunder, under the Secured Hedge Agreements and under the Secured Cash Management Agreements, the Grantors have agreed to grant a security interest in the Trademark Collateral (as defined below) as security for the Secured Obligations; and

WHEREAS, Grantors and Administrative Agent are parties to a Guarantee and Security Agreement dated as of the date hereof (the "GSA") and are concurrently entering into this Trademark Security Agreement for purposes of evidencing the grant of security in the Trademark Collateral in a form suitable for recordation in the United States Patent and Trademark Office;

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration the receipt and sufficiency of which is acknowledged, the parties hereto agree as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the GSA and, if not defined therein, then in the Credit Agreement, and used herein have the meanings given to them in the GSA or Credit Agreement, as applicable.

SECTION 2. Grant of Security Interest in Trademark Collateral. As collateral security for the payment in full when due (whether at stated maturity, acceleration or otherwise) of the Secured Obligations, each Grantor hereby pledges and grants to Administrative Agent for the benefit of the Secured Parties, a security interest in

all of such Grantor's right, title and interest in, to and under any and all of such Grantor's Trademarks, whether now owned by such Grantor or hereafter acquired, and whether now existing or hereafter coming into existence, including those United States registered and applied-for Trademarks referred to on Schedule I hereto and the goodwill connected with the use of and symbolized by the foregoing (collectively, the "Trademark Collateral"); *provided* that the Trademarks included in the Trademark Collateral do not and shall not include any Trademarks that would be rendered invalid, abandoned, void or unenforceable by reason of its being included as part of the Trademarks included in the Trademark Collateral.

SECTION 3. After-Acquired Trademarks.

(a) Should any Grantor obtain an ownership interest in, acquire or apply for registration of any Trademark which is not now a part of the Trademark Collateral,

1. the provisions of Section 2 hereof will automatically apply thereto,
2. the applicable Grantor's right, title and interest in, to and under such Trademark (together with the goodwill of the business connected with the use of and symbolized by the same) will automatically become part of the Trademark Collateral, and
3. Grantors will give the Administrative Agent written notice of any such Trademark that is the subject of an application or registration in the United States Patent and Trademark Office in accordance with the requirements of Section 6.02(a)(v) of the Credit Agreement.

SECTION 4. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Administrative Agent for the benefit of the Secured Parties pursuant to the GSA, and Grantors hereby acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Credit Agreement and the GSA. The terms and provisions of the GSA are deemed incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to irreconcilably conflict with the Credit Agreement or the GSA, the provisions of the (a) Credit Agreement and (b) GSA shall control, in that order.

SECTION 5. Governing Law; Jurisdiction; Etc. and Waiver of Jury Trial. Sections 6.07 and 6.08 of the GSA are deemed incorporated herein, *mutatis mutandis*, as if fully set forth herein.

SECTION 6. Counterparts. This Trademark Security Agreement may be executed originally and delivered by facsimile or other means of electronic transmission and in any number of counterparts, all of which, taken together, shall constitute one and the same instrument and any of the parties hereto may execute this Trademark Security Agreement by signing any such counterpart.

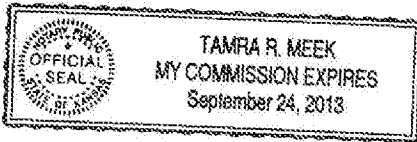
