RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, Conn-Selmer, Inc. is a corporation organized under the laws of the state of Delaware ("Conn-Selmer"); and

WHEREAS, GMAC Commercial Finance LLC, a Limited Liability Company organized under the laws of the state of Michigan ("GMAC") is the holder of a security agreement granting a security interest in certain trademarks dated September 29, 2006 and recorded in the U.S. Patent and Trademark Office ("USPTO") on October 24, 2006, at Reel/Frame number 3414/0313 (the "Security Agreement"); and

WHEREAS, GMAC desires to terminate the Security Agreement and to execute and deliver to Conn-Selmer all deeds, assignments and other instruments as may be reasonably necessary to release the security interest relating to the trademarks set forth in the Security Agreement, which trademarks include those identified on Schedule A annexed hereto and made a part hereof (the "Trademarks").

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, GMAC hereby relinquishes unto Conn-Selmer the continuing security interest in and lien on the Trademarks and otherwise assigns, grants and conveys to Conn-Selmer any and all rights GMAC may have in or to the Trademarks in order to revest in Conn-Selmer full and unencumbered title to said Trademarks.
