Release of Trademark Security Agreement

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT ("RELEASE") is made as of the 14th day of October, 2010, by **K BANK** ("LENDER"), in favor of **CBAY INC.** ("PLEDGOR").

RECITALS

Pursuant to the terms of a Trademark Security Agreement dated as of August 14, 2008, by PLEDGOR in favor of the LENDER and recorded on August 14, 2008 with the United States Patent And Trademark Office in Reel 3835, Frame 0456 ("SECURITY AGREEMENT"), PLEDGOR granted to the LENDER a security interest in Trademark Registration Number(s) and in Trademark Application Number(s) attached hereto as Exhibit A, the goodwill of PLEDGOR associated with such trademarks, and certain other assets of PLEDGOR described in the SECURITY AGREEMENT ("TRADEMARKS").

NOW, THEREFORE, in consideration of the premises, and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the LENDER agrees as follows:




