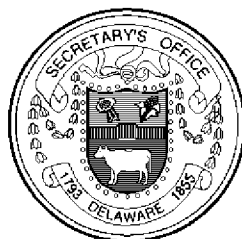

Kennametal Inc. survives the merger and may be served with process in the state of Delaware in any proceeding for enforcement of any obligation of Conforma Clad Inc., Greenfield Industries, Inc., and Rogers Tool Works, Inc. as well as for enforcement of any obligation of the surviving corporation arising from the merger, including any suit or other proceeding to enforce the right of any stockholder as determined in appraisal proceedings pursuant to the provisions of Section 262 of the General Corporation Law of the state of Delaware, and it does hereby irrevocably appoint the Secretary of State of Delaware as its agent to accept service of process in any such suit or other proceeding. The address to which a copy of such process shall be mailed by the Secretary of State of Delaware is 1600 Technology Way, Latrobe, Pennsylvania 15650 until the surviving corporation shall have hereafter designated in writing to the said Secretary of State a different address for such purpose.
