Assignor represents and warrants that it is the sole owner of all rights, title, an interest in and to the Trademarks and that the Trademarks are not subject to any lien or encumbrance and is not licensed to any person or entity. This Agreement shall be binding on the successors and assigns of Assignor and shall inure to the benefit of the successors and assigns of Assignee.
