PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK

This PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK is executed as of October 21, 2010 by Bank of America, N.A., as assignee of Fleet Capital Corporation, individually and as administrative agent (the "Administrative Agent"). Any capitalized term not otherwise defined herein shall have the meaning ascribed to it in the Trademark Assignment (as defined below).

WHEREAS, Columbus McKinnon Corporation (the "Company"), among others, entered into that certain Trademark Collateral Security and Pledge Agreement, dated as of November 21, 2002 (as amended, the "Trademark Assignment") with Fleet Capital Corporation, as amended by the First Amendment to Trademark Collateral and Pledge Agreement, dated as of March 16, 2006 and as further amended and reaffirmed by that certain Amendment and Reaffirmation of Ancillary Loan Documents dated as of December 31, 2009 by and among, inter alia, the Company and Bank of America, N.A. as administrative agent;

WHEREAS, pursuant to an assignment agreement, Bank of America, N.A. has succeeded to all rights of Fleet Capital Corporation under the Trademark Assignment;

WHEREAS, pursuant to the Trademark Assignment, the Company granted to the Administrative Agent, as security for the Obligations, a continuing security interest in all of the Company's right, title and interest in and to certain trademarks; and

WHEREAS, the Company has requested that the Administrative Agent release the liens and security interests granted to the Administrative Agent by the Company with respect to the trademark listed on Exhibit A attached hereto (the "Released Trademark").

For good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby:

(a) releases the liens and security interests granted by the Company to the Administrative Agent pursuant to any security agreement (including but not limited to the Trademark Assignment) in and to the Released Trademark; and

(b) to the extent the Administrative Agent shall be deemed to have any right, title or interest in the Released Trademark, retransfers and reassigns, without representation, warranty or recourse, to the Company all of such right, title and interest solely with respect to the Released Trademark.

(c) Except as expressly modified hereby, the Trademark Assignment shall remain in full force and effect in accordance with the provisions thereof on the date hereof.

This Partial Release of Security Interests in Trademark shall be governed by the laws of the State of New York.
