RELEASE OF TRADEMARK SECURITY INTERESTS, dated as of October 25, 2010 (this "Release"), by JPMorgan Chase Bank, N.A., as Administrative Agent and Collateral Agent. Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Collateral and Guarantee Agreement, as applicable, referred to below.

Reference is made to (i) the Amended and Restated Credit Agreement dated as of March 21, 2005, (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among HealthSouth Corporation (the "Borrower"), the Lenders from time to time party thereto, JPMorgan Chase Bank, N.A., as Administrative Agent and Collateral Agent and (ii) the Collateral and Guarantee Agreement dated as of March 21, 2005 (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement"), among the Borrower and the Collateral Agent (such documents set forth in clauses (i) and (ii), the "Security Agreements").

WHEREAS, pursuant to the Security Agreements, the Borrower granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title or interest of the Borrower in the trademarks and trademark applications set forth on Schedule I attached hereto (collectively, the "Trademarks"), which security interests were recorded with the United States Patent & Trademark Office on April 4, 2005, at Reel/Frame 3059/0339.

WHEREAS, in connection with the repayment of all Indebtedness and the termination of all Obligations under the Credit Agreement, and the release of security interests under the Loan Documents, the Borrower has informed the Administrative Agent and Collateral Agent of its desire to obtain the release of all right, title and interest of the Collateral Agent, for the benefit of the Secured Parties, in and to the Trademarks granted under the Security Agreements.

WHEREAS, pursuant to the letter agreement dated as of March 10, 2006, among the Borrower and the Administrative Agent, the Administrative Agent agreed to release any and all security interests it may have in the Trademarks pursuant to the Security Agreements.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release, cancel, relinquish and discharge any and all security interests it has against the Trademarks and reassigns all right, title and interest it has in the Trademarks to the Borrower. The Collateral Agent hereby authorizes the Borrower to make such filings with the United States Patent and Trademark Office as may be reasonably determined by the Borrower to be required to evidence the release and termination of the Collateral Agent's security interests in the Trademarks evidenced hereby. The execution and delivery of this release and any further documents and the performance of any actions by the Collateral Agent are made without representation or warranty by, or recourse to, the Collateral Agent or any of the Secured Parties.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE BORROWER'S AND THE COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
