**CONFIRMATION OF TRADEMARK ASSIGNMENT**

**THIS CONFIRMATION OF TRADEMARK ASSIGNMENT** (this "Confirmation") is entered into as of October 21, 2010 by ANDREA DEW STEELE ("Steele"), former President of Emerge: Women Leaders for a Democratic Future ("Assignor") and EMERGE AMERICA, a California not for profit corporation ("Assignee").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties confirm as follows:

On July 14, 2005, Assignor assigned to Assignee all right, title and interest in and to the Trademarks, the Goodwill and the Registrations and all rights in and to any and all causes of action heretofore or hereafter accrued or accruing for infringement or threatened or alleged infringement of the Trademarks.

This Assignment was to be binding upon the parties, their successors and/or assigns and all others acting by, through, with or under their direction, and all those in privity therewith.


