

**IN WITNESS WHEREOF**, ASSIGNOR and ASSIGNEE have caused this Assignment to be executed by their respective duly authorized representatives.



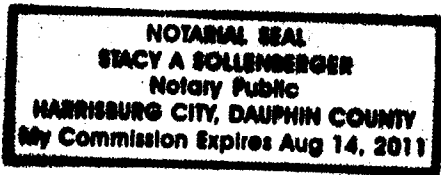
