TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is entered into as of October 1, 2010, by and between **MORTON INTERNATIONAL, LLC**, an Indiana limited liability company (hereinafter "Assignor"); and **MORTON SALT, INC.**, a Delaware corporation having an address of 123 North Wacker Drive, Chicago, Illinois 60606 (hereinafter "Assignee").

WITNESSETH:

WHEREAS, the Assignor holds all right, title, and interest in and to the registered trademarks and trademark applications listed in Schedule A attached hereto (the "Assigned Trademarks"), and the goodwill of the business symbolized thereby;

WHEREAS, Assignee desires to obtain all of Assignor's right, title, and interest in and to the Assigned Trademarks, and the goodwill associated therewith; and

WHEREAS, Assignor is willing to assign its right, title, and interest in and to the Assigned Trademarks, and the goodwill associated therewith to the Assignee.

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, the parties hereto agree as follows:

1. **Assignment.** Assignor, being the sole and exclusive legal and beneficial owner of the Assigned Trademarks, hereby sells, assigns, and transfers to Assignee: (a) all of Assignor's right, title, and interest worldwide in and to the Assigned Trademarks, and the goodwill associated with the Assigned Trademarks, and (b) all claims that can or may be asserted by Assignor arising out of or relating to the use or ownership of any of the Assigned Trademarks, including but not limited to trademark infringement damages, associated with the Assigned Trademarks. Assignee hereby accepts such assignment.

2. **Further Assurances.** Assignor agrees to execute all documents and assist in all proceedings to perfect, register, or record the rights of the Assignee to the Assigned Trademarks as Assignee may reasonably deem appropriate. If Assignor does not, within fifteen (15) days of presentment, return the requested executed documents, then Assignee is hereby granted a limited power of attorney to execute all such documents on behalf of Assignor (which power of attorney is coupled with an interest and is irrevocable).

3. **Governing Law.** This Assignment shall be construed in accordance with, and this Assignment and all matters arising out of or relating in any way whatsoever hereto (whether in contract, tort or otherwise) shall be governed by, the law of the State of New York.





The provisions of the Assignment that by their nature would survive its termination or expiration will survive indefinitely. 
