RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE is made as of October 22, 2010 by LANDESBANK BADEN-WÜRTTEMBERG, as Security Agent ("**Secured Party**").

WITNESSETH:

WHEREAS, Secured Party and AMERICAN BOA, INCORPORATED ("**Company**"), were parties to that certain Trademark Security Agreement, dated as of April 25, 2006 (the "**Security Agreement**"), pursuant to which Company granted a security interest to Secured Party in, *inter alia* certain Trademark Collateral (as defined in the Security Agreement), including, without limitation, those trademarks set forth on Schedule 1 (the "**Trademarks**"), and the goodwill associated therewith; and

WHEREAS, Secured Party recorded a security interest in certain of those Trademarks with the Assignment Division of the United States Patent and Trademark Office on May 25, 2006 at Reel 003316, Frame 0312.

NOW THEREFORE, in consideration for the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:


1. Secured Party hereby releases its security interest in the Trademark Collateral originally granted to Secured Party pursuant to the Security Agreement.
2. Secured Party, to the extent granted in the Security Agreement, hereby assigns, grants and otherwise re-conveys to Company, without any representation, recourse or undertaking by Secured Party, all of its right, title and interest in and to the Trademark Collateral and all goodwill associated therewith originally granted to Secured Party pursuant to the Security Agreement.
3. Upon the request of Company, Secured Party further agrees to execute all documents necessary to demonstrate and confirm the parties' intent under this Release of Trademark Security Interest.

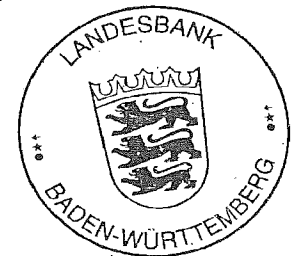

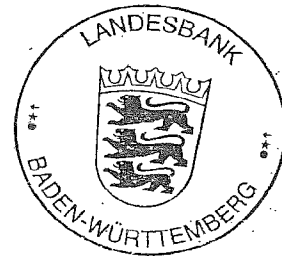

General Conditions for the list of authorized signatures of Landesbank Baden-Württemberg*

Legally binding obligations of Landesbank Baden-Württemberg are made in writing by two authorized signatories. Authorized signatories of group A may sign jointly with any other authorized signatory, whereas authorized signatories of group B may only sign jointly with an authorized signatory of group A.

Exceptions:

1. With respect to foreign operations, payment orders and checks up to € 10,000 or the equivalent in other currencies require the signature of only one signatory of group A or B.
2. Automatically produced documents such as statements of accounts, book entries and advices are legally binding for Landesbank Baden-Württemberg without any signature.

Landesbank Baden-Württemberg's payment orders in excess of € 10,000 or the equivalent in other currencies - with the exception of transfers to Landesbank Baden-Württemberg's own accounts - are always effected by tested cable or telex or by S.W.I.F.T.

Business transactions executed in branches are signed by the persons whose names are on display in the branches as well as by authorized signatories of groups A and B.

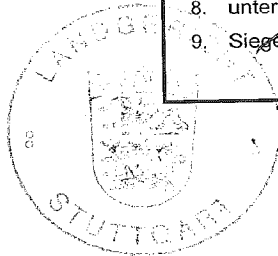
