IP SUPPLEMENT

This IP SUPPLEMENT (this "Supplement") dated as of OCTOBER 19, 2010 is delivered pursuant to and supplements the Trademark Security Agreement dated as of November 8, 2006 (said Trademark Security Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the "**Trademark Security Agreement**"), among Neways, Inc., a Utah corporation ("**Neways**") and LTM Enterprises, Inc., a Nevada corporation (the "**Borrower**") (the Borrower together with Neways, the "**Pledgors**"), and Silver Point Finance, LLC, in its capacity as Collateral Agent ("**Collateral Agent**"). Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Trademark Security Agreement.

Pledgors grant to Collateral Agent a security interest in all of the Pledgors' right, title and interest in and to the Subject Trademarks set forth on Schedule A annexed hereto. All such Trademark Collateral shall be deemed to be part of the Trademark Collateral and shall be hereafter subject to each of the terms and conditions of the Trademark Security Agreement.
