## **RELEASE OF ASSIGNMENT FOR SECURITY - TRADEMARKS**

WHEREAS, pursuant to that certain Assignment for Security Trademarks, dated as of January 22, 2008 (the "Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 3702, Frame 8 on January 23, 2008, Command Alkon Incorporated, a Delaware corporation ("Releasee"), pledged, conveyed, sold, assigned and set over unto Silver Point Finance, LLC ("Releasor") and granted to Releasor, as collateral agent for itself and various other financial institutions, a continuing security interest in all right, title and interest of Releasee in and to the trademark COMMANDASSIST, which is the subject of U.S. Trademark Registration Number 3,273,909, and all common law rights to such trademark, together with, among other things, the good-will of the business symbolized thereby and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Trademark"); and

WHEREAS, Releasor acknowledges and agrees that all of Releasee's obligations with respect to the Security Agreement have now been fully and completely satisfied and that the security interest granted has been and hereby is terminated;

WHEREAS, Releasor desires to fully, completely and formally release its security interest in and to the Trademarks and in and to any and all other trademarks of Releasee, and to record such release with the U.S. Patent and Trademark Office;

WHEREAS, Releasee has requested and Releasor has agreed to provide a document suitable for same.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor does hereby fully, completely and formally re-assign, release, relinquish and discharge its continuing security interest and any other interest it may have in the Trademark and in any and all other trademarks of Releasee.
