TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT is entered into as of the 5th day of October, 2010, by and between Sun Healthcare Group, Inc. ("Sun") and SHG Services, Inc. ("SHG") (collectively referred to as the "Parties").

WHEREAS, Sun has used the trademark SUN HEALTECARE GROUP (the "Mark") in connection with the provision of healthcare related services, including but not limited to hospitals, retirement homes, rehabilitation services, special health care, therapy, and similar services;

WHEREAS, Sun has registered the Mark with the United States Patent and Trademark Office ("USPTO") under registration no. 3621931;

WHEREAS, Sun wishes to assign all of its interest in the Mark to SHG, and SHG wishes to accept said assignment;


WHEREAS, SHG intends to provide similar services under the Mark as those offered by Sun;

NOW, THEREFORE, in consideration of this agreement, as well as an acknowledgement that any liability created by the use of the Marks by Sun shall remain with Sun, which is acknowledged by the parties as being sufficient and proper, the Parties have agreed as follows:

1. **Assignment.** Sun irrevocably assigns to SHG all rights, title and interest, including all common law rights, in the United States and in the world in and to the Marks, and all goodwill associated with and symbolized by said Marks, and to all business assets pertaining to said Marks, such that SHG shall be considered the successor in interest in and to the Marks.


