**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** dated as of October 20, 2010, by CANOPY VENTURES I, L.P., a Utah limited partnership (the "*Canopy*").


**WHEREAS**, iArchives, Inc., a Utah corporation (the "*Company*") and Canopy entered into an Intellectual Property Security Agreement, dated as of January 16, 2009 (the "*Security Agreement*"), which Security Agreement was recorded with the United States Patent and Trademark Office on February 11, 2009, at Reel 022235, Frame 0754 for certain Patents (as defined below) and Reel 3933, Frame 0676 for certain Trademarks (as defined below), for the purpose of collateral security for all indebtedness and obligations of the Company to Canopy arising under the Note (as defined in the Security Agreement);

The Patents and the Trademarks are referred to herein collectively as the "*Intellectual Property*"; and

**WHEREAS**, Canopy has agreed to terminate and release its security interest in the Intellectual Property as herein provided:

**NOW, THEREFORE**, for valuable consideration Canopy hereby terminates and releases its security interest in the Intellectual Property, including, without limitation, the Patents listed on Exhibit A hereto and the Trademarks listed on Exhibit B hereto, and Canopy hereby assigns and transfers to the Company, without representation, warranty or recourse, all of Canopy's right, title and interest in and to such Intellectual Property, effective as of the date set forth above.
