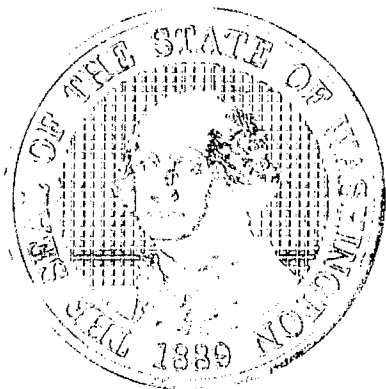

**ARTICLES OF AMENDMENT OF
THE THIRD AMENDED AND RESTATED
ARTICLES OF INCORPORATION OF
PLAS2FUEL CORPORATION**


These Articles of Amendment to the Third Amended and Restated Articles of Incorporation (the "Articles") of Plas2Fuel Corporation, a Washington corporation (the "Corporation"), are hereby executed by said Corporation pursuant to the provisions of RCW 23B.01.200 and RCW 23B.10.060 as follows:

1. The name of the corporation is Plas2Fuel Corporation.
2. Article 1 of the Articles is amended and restated in its entirety to read as follows:
"The name of this corporation (the "**Corporation**") is Agilyx Corporation."
3. No exchange, reclassification or cancellation of issued shares shall be effected by the foregoing amendment.
4. The foregoing amendment was adopted by and recommended to the shareholders by the Board of Directors of the Corporation on May 26, 2010.
5. The foregoing amendment was duly approved by the shareholders in accordance with the provisions of RCW 23B.10.030 and 23B.10.040 on June 7, 2010.
