NOTICE OF RELINQUISHMENT OF SECURITY INTEREST


WHEREAS on or about December 13, 2000, Pepe Jeans London, LLC, a Delaware limited liability company (the "Grantor") granted to Century Business Credit Corporation, a New York Corporation, (the "Lender"), a security interest in certain intellectual property and related goodwill associated therewith ("Security Interest"), including but not limited to the trademark applications and/or registrations listed on Schedule A to this Notice; and

WHEREAS, the Security Interest was memorialized in a Security Agreement and/or Notice of Security Agreement (collectively and individually, "Security Agreement") which was executed on or about December 13, 2000 and recorded with the United States Patent and Trademark Office at Reel 2211, Frame 0169; and

WHEREAS, the Lender has released and hereby intends to release and relinquish all rights relating to the above intellectual property and any other intellectual property of the Grantor and all proceeds thereof including the goodwill associated therewith, including but not limited to its security interest in any trademarks.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Lender hereby relinquishes, releases and terminates its security interest granted by the Grantor pursuant to the Security Agreement, including specifically the intellectual property identified in Schedule A.
