## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of November 3, 2010 by **GE BUSINESS FINANCIAL SERVICES INC.**, formerly known as Merrill Lynch Business Financial Services Inc., as Second Lien Collateral Agent ("**Second Lien Collateral Agent**"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Assignment (as defined below).

### WITNESSETH:

WHEREAS, **NATIONAL PROCESSING COMPANY**, a Nebraska corporation (formerly known as RPSI, Inc., a Nebraska corporation), **BEST PAYMENT SOLUTIONS, INC.**, an Illinois corporation, **ACQUISITION COMPANY 2006A, INC.**, a Delaware corporation (each a **Grantor** and collectively, the "**Grantors**") and Second Lien Collateral Agent are parties to a Second Lien Trademark Security Agreement dated as of September 29, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "**Assignment**"), pursuant to which Grantors granted a security interest to Second Lien Collateral Agent in certain trademarks ("**Trademarks**") and Trademark Rights (as defined below) as security for certain obligations owing by Grantors to Second Lien Collateral Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on October 9, 2006, at Reel 3404, Frame 0547; and

WHEREAS, Grantors have requested that Second Lien Collateral Agent release its security interest in the Trademarks and Trademark Rights and reassign the same to the Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Second Lien Collateral Agent hereby releases its security interest in all of Grantors' right, title and interest in and to the following (collectively the "**Trademark Rights**"):

(1) each Trademark, Trademark registration and Trademark application, including, without limitation, the Trademarks, Trademark registrations (together with any reissues, continuations or extensions thereof) and Trademark applications referred to in Schedule 1 annexed hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, Trademark registration and Trademark application;

(2) each Trademark license and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark license; and


(3) all products and proceeds of the foregoing, including, without limitation, any claim by Grantors against third parties for past, present or future (a) infringement or dilution of any Trademark or Trademark registration including, without limitation, the Trademarks and Trademark registrations referred to in Schedule 1 annexed hereto, the Trademark registrations issued with respect to the Trademark applications referred in Schedule 1 and the Trademarks licensed under any Trademark license, or (b) injury to the goodwill associated with any Trademark, Trademark registration or Trademark licensed under any Trademark license.

2. Second Lien Collateral Agent hereby reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by Second Lien Collateral Agent, all of Second Lien Collateral Agent's right, title and interest in and to the Trademarks and the Trademark Rights.
