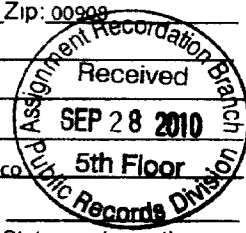

**FIRST AMENDMENT TO TRADENAME COLLATERAL ASSIGNMENT AND  
SECURITY AGREEMENT**

This First Amendment to Tradename Collateral Assignment and Security Agreement (the "Amendment") dated as of the 15<sup>th</sup> day of September, 2010, by and between:

**FIRSTBANK PUERTO RICO** (hereinafter the "Lender"), a banking corporation organized and existing under the laws of the Commonwealth of Puerto Rico, herein represented by its Vice President, **MR. NELSON GONZÁLEZ**, who is of legal age, married, executive and resident of San Juan, Puerto Rico; and

**PUERTO RICO COFFEE ROASTERS, LLC** (hereinafter the "Assignor"), a limited liability company organized and existing under the laws of the Commonwealth of Puerto Rico. herein represented by its Senior Vice President and Chief Financial Officer, **MR. ALBERTO RIVERA**, of legal age, married, an executive and resident of San Juan, Puerto Rico.

**WITNESSETH:**


**WHEREAS**, Lender has agreed to extend credit to Assignor pursuant to the terms and subject to the conditions set forth in that certain Revolving Credit and Term Loan Agreement dated September 11, 2008, as amended by that certain letter agreement dated August 18, 2010 and by a First Amendment to Revolving Credit and Term Agreement dated August 27, 2010, between the Lender and Assignor (as it may be from time to time further amended, supplemented, extended, renewed or otherwise modified hereinafter called the "**Loan Agreement**"), and the documents, instruments, and agreements ancillary thereto (as any of the same may be amended, extended or replaced from time to time, the Loan Documents); and


**WHEREAS**, Lender and Assignor entered into a Tradename Collateral Assignment and Security Agreement dated September 11, 2008 (the "Agreement"). Capitalized terms not otherwise defined herein shall have the meaning assigned to such term in the Agreement;

**WHEREAS**, it is a condition to continue to extend credit under Loan Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, that the Assignor grant a security interest in the additional Tradenames as security for the Obligations.

**NOW THEREFORE**, in consideration of the premises, the parties hereto agree as follows

1. Effective the date of execution of this Amendment, **Schedule A** of the Agreement is modified to include the trademarks, service marks, trade names identified in **Schedule I** hereof.

  
2. Assignor hereby ratifies all of its representations with respect to the original Tradenames included in **Schedule A** and hereby affirms that they are true and correct with respect to those additional Tradenames identified in **Schedule I** hereof, except as set forth in that certain letter dated September , 2010.




