FIRST LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE

This FIRST LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE (the “**IP Security Release**”), dated October 21, 2010, is made by Credit Suisse AG, Cayman Islands Branch (f/k/a Credit Suisse, Cayman Islands Branch) (“**CS**”), as collateral agent (the “**Collateral Agent**”) for the Secured Parties, in favor of the persons listed on Exhibit A (collectively, the “**Grantors**”). All capitalized terms used herein and not otherwise defined shall have the meaning assigned to such terms in the Credit Agreement (as defined below).

WHEREAS, Canon Communications LLC (as surviving entity of the Merger), a Delaware limited liability company, has entered into a First Lien Credit Agreement dated as of May 31, 2005 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), with Canon Communications Holdings, LLC, a Delaware limited liability company, the Subsidiary Guarantors, CS, as Administrative Agent and as Collateral Agent, and the Lenders party thereto;

WHEREAS, under the terms of the Credit Agreement, the Grantors granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in certain Collateral (as separately defined in each of the IP Security Agreement, the IP Security Agreement Supplement, and the Second IP Security Agreement Supplements) and Additional Collateral (as defined in the First IP Security Agreement Supplement) of the Grantors, and executed that certain First Lien Intellectual Property Security Agreement dated May 31, 2005 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**IP Security Agreement**”), that certain First Lien Intellectual Property Security Agreement Supplement, dated as of May 31, 2005 (the “**IP Security Agreement Supplement**”), that certain First Lien Intellectual Property Security Agreement Supplement, dated as of June 15, 2006 (the “**First IP Security Agreement Supplement**”), and those certain First Lien Intellectual Property Security Agreement Supplements, dated February 16, 2010 (the “**Second IP Security Agreement Supplements**”);

WHEREAS, the IP Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on June 13, 2005, at Reel 3173 and Frame 0419, and with the United States Copyright Office on June 14, 2005 in Volume 3525 and Pages 678;

WHEREAS, the First IP Security Agreement Supplement was recorded with the Trademark Division of the United States Patent and Trademark Office on June 22, 2006, at Reel 3336 and Frame 0129, and with the United States Copyright Office on July 3, 2006 in Volume 3540 and Page 605; and

WHEREAS, the Second IP Security Agreement Supplements were recorded with the Trademark Division of the United States Patent and Trademark Office on February 23, 2010, at Reel 4154 and Frame 0295 and on February 24, 2010, at Reel 4154 and Frame 0876.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Grant of Security. The Collateral Agent hereby terminates and releases its security interest in and to the Collateral (as separately defined in each of the IP Security Agreement, the IP Security Agreement Supplement, and the Second IP Security Agreement Supplements) and Additional Collateral (as defined in the First IP Security Agreement Supplement) and releases and conveys to the Grantors, without recourse, representation or warranty of any kind, all of the Collateral Agent's right, title and interest in and to the Grantors' right, title and interest in and to such Collateral and Additional Collateral, including, without limitation, all of the foregoing listed on Exhibit B.

SECTION 2. Recordation. The Collateral Agent authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this IP Security Release.

SECTION 3. Governing Law. This IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.
