**RELEASE OF SECOND LIEN SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of September 27, 2010, is made by NEXBANK, SSB, in its capacity as successor administrative agent and collateral agent (the "Administrative Agent") for the Secured Parties pursuant to the Second Lien Credit Agreement, dated as of July 2, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Borrower, Holdings, the Lenders and the L/C Issuers from time to time party thereto and the Administrative Agent.

**WITNESSETH**

WHEREAS, each of the entities listed on the signature pages to the Intellectual Property Trademark Security Agreement (as hereinafter defined), the Trademark Security Agreement (as hereinafter defined), and the Intellectual Property Copyright Security Agreement (as hereinafter defined) (each a "Grantor" and collectively, the "Grantors") is party to the Guaranty and Security Agreement, dated as of July 2, 2007 (the "Security Agreement"), and pledged to guarantee the Obligations (as defined in the Credit Agreement) of the Borrower;

WHEREAS, pursuant to the Security Agreement, the Grantors executed (i) the Intellectual Property Security Agreement [Trademark Security Agreement], dated as of July 2, 2007 (the "Intellectual Property Trademark Security Agreement"), by and among the Grantors and the Administrative Agent for the Secured Parties and recorded with the U.S. Patent and Trademark Office on August 10, 2007 at Reel/Frame No. 3598/0982, and (ii) the Trademark Security Agreement, dated as of March 12, 2009 (the "Trademark Security Agreement"), by and among the Grantors and the Administrative Agent and recorded with the U.S. Patent and Trademark Office on March 19, 2009 at Reel/Frame No. 3955/0432, pursuant to which each Grantor granted to the Administrative Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under its Trademarks (the "Trademark Collateral");

WHEREAS, pursuant to the Security Agreement, the Grantors executed the Intellectual Property Security Agreement [Copyright Security Agreement], dated as of July 2, 2007 (the "Intellectual Property Copyright Security Agreement") by and among the Grantors and the Administrative Agent for the Secured Parties and recorded with the U.S. Copyright Office on September 17, 2007 at V3556 D275, pursuant to which each Grantor granted to the Administrative Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under its Copyrights (the "Copyright Collateral");

WHEREAS, pursuant to that certain Successor Agent Agreement, dated as of February 22, 2010, by and among General Electric Capital Corporation, NexBank, SSB, Medical Staffing Network, Inc., Medical Staffing Holdings, LLC, Medical Staffing Network Holdings, Inc. and the lenders party thereto, NexBank, SSB has succeeded to the role of Administrative Agent with respect to the Credit Agreement, the Security Agreement and each other Loan Document (as defined in the Credit Agreement); and

WHEREAS, capitalized terms used but not defined in this Release shall have the meaning assigned to such terms in the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent agrees as follows:

The Administrative Agent, on its own behalf and on behalf of the Secured Parties, hereby relinquishes, terminates, cancels and releases any and all right, title and interest it may have or have acquired through the Security Agreement, Intellectual Property Trademark Security Agreement, Trademark Security Agreement, Intellectual Property Copyright Security Agreement or otherwise, in and to the Trademark Collateral and Copyright Collateral, including the trademarks and copyrights listed on Schedule I attached hereto and incorporated herein by reference (collectively, the “Released Collateral”).

The parties hereto shall cause this Release to be filed with the United States Patent and Trademark Office and the United States Copyright Office for the purpose of recording the release of the Secured Parties’ security interest in the Released Collateral.

IN WITNESS WHEREOF, the Administrative Agent has executed this Release as of the date first set forth above.
