ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF  
PRIME RESIDENTIAL PROPERTIES, INC.

Pursuant to the provisions of Article 4.01 of the Texas Business Corporation Act, Prime Residential Properties, Inc., a Texas corporation (the "*Corporation*"), adopts the following Articles of Amendment to its Articles of Incorporation, which changes the name of the Corporation.

ARTICLE ONE

The name of the corporation is Prime Residential Properties, Inc., a Texas corporation. The filing number issued to the Corporation by the Secretary of State is 117614200.

ARTICLE TWO

The following amendment to the Articles of Incorporation and any subsequent amendments thereto was adopted by the Corporation:

1. Article 1 of the Articles of Incorporation is hereby amended so as to read as follows:

The name of the Corporation is ONEprop, Inc.


ARTICLE THREE
