I, Mr. John Hengel, the Vice President of Finance of Jason Incorporated, the above-referenced assignee, hereby declare the following in support of the accompanying termination of security interest.

1. Assignee granted security interests in its assets in favor of Assignor as evidenced by the Uniform Commercial Code financing statements attached as Exhibit A.

2. Assignor recorded its security interest in the patents and marks listed on Exhibit B (the "Patents" and "Marks") pursuant to the document recorded at the reel and frame numbers identified on Exhibit A for each mark.

3. Assignor released its security interest in Assignee's assets, including the Patents and Marks, as evidenced by the Uniform Commercial Code termination statement attached as Exhibit C. The obligations underlying the security interest have been satisfied and Assignor no longer has a security interest in Assignee's assets.



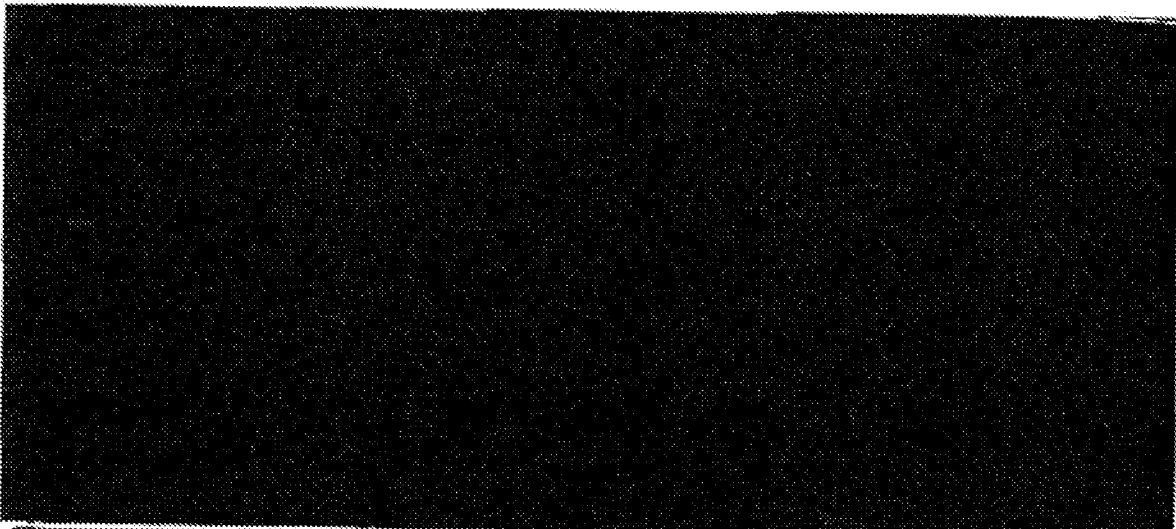
