TERMINATION AND RELEASE
(Trademarks)

This TERMINATION AND RELEASE is dated as of August 13, 2010, and made by Amalgamated Bank, a New York banking corporation (the "Secured Party"), in favor of Merisel, Inc., a Delaware corporation (the "Pledgor").

WITNESSETH:

WHEREAS, the Pledgor granted a security interest in certain Collateral (as hereinafter defined) to the Secured Party (the "Security Interest"); and

WHEREAS, the Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office on March 9, 2005, at Reel 3043, Frame 0414; and

WHEREAS, additional Security Interests in Collateral were granted to the Secured Party by Pledgor and its wholly owned subsidiaries, Merisel Americas, Inc., Color Edge LLC and Fuel Digital LLC which were not recorded with the Trademark Division; and

WHEREAS, the Secured Party now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby terminates and releases the Security Interest in the Collateral.


Collateral. The term "Collateral," as used herein, shall mean all of the Pledgor's right, title and interest of every kind and nature in the trademarks and service marks set forth on Schedule A attached hereto, whether or not recorded, and (i) all registrations, applications, recordings and common-law rights relating thereto; (ii) all reissues, continuations, continuations-in-part or extensions thereof/ all renewals thereof; (iii) all income, license royalties, damages and payments now and hereafter due and/or receivable with respect thereto, including, without limitation, all damages and payments receivable for past, present and/or future infringements thereof; (iv) the right to sue for past, present and/or future infringements thereof; (v) all rights corresponding thereto throughout the world; and (vi) the goodwill of the Pledgor's business connected with or symbolized by the foregoing.

Further Assurances. The Secured Party hereby agrees to execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interests contemplated hereby.
