TERMINATION OF SECURITY INTEREST FOR TRADEMARKS

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby terminates all of the Secured Party's security interests in and to the Trademark Collateral, including, without limitation, that interest as set forth at Reel 2507, Frame 0275.

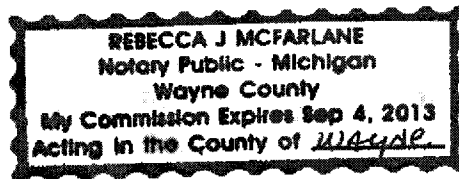
