**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

WHEREAS McBride Electric, Inc., a Kansas corporation ("Grantor"), entered into an Intellectual Property Security Agreement (the "Security Agreement") in conjunction with a Credit Agreement dated July 2, 2007 (the "Credit Agreement") with Golub Capital Incorporated, a New York corporation ("Golub"), notice of which was recorded July 2, 2007 at the United States Patent and Trademark Office at Reel 3572, Frame 0558.

WHEREAS, under the terms of the Security Agreement, Grantor granted to Golub, as administrative agent for the lenders party to the Credit Agreement ("Lenders"), a continuing security interest (the "Security Interest") in favor of Golub, as administrative agent for the Lenders, in and to certain of Grantor's intellectual property.

WHEREAS, Grantor has sold certain of its assets, including the trademarks listed in Schedule A, the registrations and application for registration thereof listed in Schedule A, and the goodwill symbolized by such trademarks (collectively, the "Trademarks"), to System Electric, Inc., and Golub, as administrative agent for the Lenders, has agreed to terminate and release the Security Interest in such Trademarks.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, Golub, for itself and on behalf of the Lenders, hereby releases the Security Interest in the Trademarks.


