ROHM AND HAAS CHEMICALS LLC

WHEREAS, **ROHM AND HAAS CHEMICALS LLC**, a Delaware limited liability company (hereinafter "Assignor"), and **AKZO NOBEL N.V.**, a public limited liability company organized under the laws of the Netherlands (hereinafter "Purchaser"), have entered into a Purchase and Sale Agreement dated as of November 11, 2009 ("Agreement"), governing the purchase and sale of Assignor's powder coatings business (hereinafter the "Business"), to Purchaser;

WHEREAS, Assignor is the owner and assignee or beneficial owner of all interest in certain items of the Owned Intellectual Property as defined in the Agreement, specifically the Patents and Marks set forth, respectively, in the attached Patent Schedule A and Marks Schedule B used primarily in the Business; and

WHEREAS, Purchaser desires that its Affiliate, **AKZO NOBEL COATINGS INTERNATIONAL B.V.**, a limited liability company organized under the laws of The Netherlands ("Assignee") acquire all of Assignor's right, title and interest therein.

Terms appearing in initial capital letters in this Intellectual Property Assignment and not otherwise defined herein, shall have the meanings given to them in the Agreement.

NOW THEREFORE, to all whom it may concern be it known that for and in consideration of good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby sell, transfer and assign unto said Assignee, its successors, assigns, and legal representatives, Assignor's entire right, title and interest in and to the aforesaid Patents and Marks, and the goodwill associated therewith, including: (i) the inventions as described in the said Patents, together with Assignor's entire right, title and interest in and to any patents as may issue from any patent application copending with the Patents, whether now or later filed, including but not limited to continuations, divisional, reissues, and reexaminations of said Patents; said inventions, applications and Patents to be held and enjoyed by said Assignee for its own use and behalf, and for its successors, assigns and legal representatives, to the full end of the term and throughout the countries for which said Patents have been granted, or for which Patents may be granted; (ii) the Marks, service marks, and tradenames, whether registered or not, and the goodwill associated therewith, as fully and entirely as the same would have been held by Assignor had this assignment and sale not been made. Assignor hereby conveys all of Assignor's rights arising under or pursuant to any and all international agreements, treaties or laws relating to the protection of intellectual property filing any patent applications copending with the said Patents, or by filing any trademark applications in any country or jurisdiction that is party to any such agreement, treaty or law; Assignor hereby acknowledges that this Intellectual Property Assignment, being of

Assignor's entire right, title and interest in and to the aforesaid Patents and Marks, carries with it the right in Assignee to apply for and obtain from any competent authorities in any state (a) any patents copending with the said Patents or covering inventions for which patent applications have not yet been filed, or (b) any trademark applications for any of the Marks, service marks, and tradenames in countries where such applications have not been filed by attorneys and agents of Assignee's selection, as well as the right to procure the grant of all trademark registrations to Assignee for its own name as assignee of Assignor's entire right, title and interest therein; and, Assignor hereby acknowledges that this assignment carries with it the right in Assignee to enforce its rights under said under said Patents, patent applications, Marks, service marks and tradenames.

Assignor hereby further agrees for itself and its successors, assigns and legal representatives to execute upon request any other lawful documents and likewise to perform any other lawful acts which may be deemed necessary to secure fully the aforesaid Patents and Marks to said Assignee, its successors, assigns, and legal representatives, but at the expense and charge of Assignee, including the execution of applications for patents or trademarks in foreign countries; the execution of substitution, reissue, divisional or continuation applications for patents; and preliminary or other statements or the giving of testimony in any proceeding in which the inventions or any application or patent directed thereto or any trademark, service mark, or tradename may be involved.

Still further, Assignor hereby authorizes and requests the patent office or trademark office, respectively, acting within its jurisdiction to issue any patents as shall be granted upon any application or applications copending with the Patents to the Assignee, its successors, assigns, and legal representatives and to register any Marks to the Assignee, its successors, assigns, and legal representatives.

This Intellectual Property Assignment is in all events subject to the terms and conditions of the Agreement.
