## NOTICE OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF SECURITY INTEREST IN TRADEMARKS is made the 17th day of June, 2010 by and between CHASE CAPITAL CORPORATION, as administrative agent (the "Administrative Agent"), and VERDI, LLC, a Wisconsin limited liability company ("Verdi").

Verdi and the Administrative Agent acknowledge the following:

A. Pursuant to a Second Amended and Restated Senior Subordinated Secured Credit Agreement dated as of September 30, 2009, as amended to date (as so amended and as further amended, restated or otherwise modified from time to time, the "Credit Agreement"; capitalized terms not otherwise defined herein have the meaning assigned to such terms in the Credit Agreement) by and among the GLK Foods, LLC (f/k/a Great Lakes Kraut Company, LLC, a Wisconsin limited liability company (the "Borrower"), Verdi, the other Loan Parties party thereto, the lenders from time to time party thereto (the "Lenders"), and Administrative Agent, the Lenders have agreed to make loans and provide financial accommodations to the Borrower on the terms and conditions set forth therein.

B. To secure the Secured Obligations, Verdi has granted to the Administrative Agent for the benefit of the Administrative Agent, the Lenders, the Issuing Bank, the Swingline Lender, Chase, any Affiliate of Chase or a Lender which has Swap Obligations or Banking Services Obligations owing to it (collectively, the "Benefited Parties"), a security interest in substantially all of its assets pursuant to the terms and conditions of an Amended and Restated Pledge and Security Agreement dated as of August 18, 2008, as amended to date (as so amended and as further amended, restated or otherwise modified from time to time, the "Security Agreement") by and among the Loan Parties and the Administrative Agent.

C. Verdi owns the trademarks listed on Exhibit A attached hereto (the "Trademarks"), which Trademarks have been granted by, or applications therefor are pending before, the United States Patent and Trademark Office.

D. Verdi has granted to the Administrative Agent for the benefit of the Benefited Parties, a security interest in the Trademarks on the terms and conditions set forth in the Security Agreement.

E. Pursuant to the Security Agreement, Verdi has granted to the Administrative Agent for the benefit of the Benefited Parties, a security interest in and to the Trademarks and application therefor, now owned or from time to time after the date hereof owned or acquired by Verdi, and in and to all proceeds and benefits thereof.
