RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of November 1, 2010, by FIFTH THIRD BANK, an Ohio banking corporation, in its capacity as Administrative Agent (in such capacity, “**Grantee**”), in favor of EXAMWORKS, INC., a Delaware corporation, for itself and as successor by merger to Crossland Medical Review Services, Inc., SOUTHWEST MEDICAL EXAMINATION SERVICES, INC., a Texas corporation, THE RICWEL CORPORATION, an Ohio corporation, CFO MEDICAL SERVICES, LLC, a New Jersey limited liability company, DIAGNOSTIC IMAGING INSTITUTE, INC., a Texas corporation, RICWEL OF WEST VIRGINIA, LLC, a West Virginia limited liability company, PACIFIC BILLING SERVICES, INC., a Texas corporation, EXAMWORKS REVIEW SERVICES, LLC, f/k/a Set-Aside Solutions, LLC, a Delaware limited liability company, MARQUIS MEDICAL ADMINISTRATORS, INC., a New York corporation, IME SOFTWARE SOLUTIONS, LLC, a Michigan limited liability company, FLORIDA MEDICAL SPECIALISTS, INC., a New Jersey corporation, EXAMWORKS EVALUATIONS OF NEW YORK, LLC, a New York limited liability company, EXAMWORKS CANADA, INC., a Delaware corporation, NETWORK MEDICAL REVIEW COMPANY, LTD., an Illinois corporation, NETWORK MEDICAL MANAGEMENT COMPANY, LTD., an Illinois corporation, INSURANCE APPEALS, LTD., an Illinois corporation, ELITE PHYSICIANS, LTD., an Illinois corporation, WORKERSFIRST, INC., an Illinois corporation, EXIGERE CORPORATION, a Washington corporation, and EXAMWORKS EUROPE, INC., a Delaware corporation (collectively, “**Grantor**”).

RECITALS

WHEREAS, pursuant to the terms and conditions of that certain (a) Loan and Security Agreement dated as of December 18, 2009, among Grantor, the lenders party thereto (“**Lenders**”), and Grantee (as amended, the “**Loan Agreement**”), and (b) Intellectual Property Security Agreement dated as of December 18, 2009, among Grantor and Grantee (as amended, the “**Security Agreement**”), Grantor granted to Grantee a security interest and collateral assignment (“**Lien**”) in, among other items, the intellectual property owned by Grantor (the “**IP Collateral**”);

WHEREAS, the original Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on December 21, 2009, at Reel 4118 and Frame 0278, and amendments thereto were recorded on January 12, 2010, at Reel 4129 and Frame 0487; January 12, 2010, at Reel 4129 and Frame 0499; July 1, 2010, at Reel 4235 and Frame 0239; August 10, 2010, at Reel 4258 and Frame 0001; September 1, 2010, at Reel 4271 and Frame 0097; and September 7, 2010, at Reel 4273 and Frame 0502.

WHEREAS, pursuant to the terms and conditions of that certain Payoff Letter dated as of even date herewith, Grantee has consented to the release of the Lien in, among other items, the IP Collateral identified on Exhibit A attached hereto (collectively, the “**Trademarks**”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby agrees as follows:

1. Grantee's Lien in the IP Collateral granted pursuant to the Loan Agreement and the Security Agreement is hereby terminated and released.

2. Grantee agrees to execute, acknowledge and deliver all such further instruments and to take all such further action as may be reasonably requested in writing as is required in order to more fully and effectively carry out the purpose of this Release, all at the sole cost and expense (including, without limitation, reasonable attorneys' fees of Grantee) of Grantor.

3. Notwithstanding anything to the contrary contained in herein or in any other releases, instruments, certificates or documents furnished in connection herewith (if any), the contingent indemnity obligations of each Grantor and its respective Affiliates to the Grantee and Lenders under or in respect of the Loan Agreement and the Security Agreement that expressly survive termination of such agreements shall continue in full force and effect in accordance with their respective terms.
