**TRADEMARK ASSIGNMENT**

This Trademark Assignment (this "Assignment") dated as of June 1, 2010, is delivered pursuant to the Closing under that certain Asset Purchase Agreement (as defined below) by Abbott Laboratories, an Illinois corporation ("Assignor") to DiaSorin S.p.A., a corporation organized under the laws of the Republic of Italy (the "Assignee"). Capitalized terms not otherwise defined herein have the meaning ascribed to them in the Asset Purchase Agreement.

WHEREAS, Assignor and certain of its Affiliates ("Sellers"), and Assignee and certain of its Affiliates ("Buyers") have entered into that certain Asset Purchase Agreement, dated as of March 9, 2010 (the "Asset Purchase Agreement"), pursuant to which Sellers have sold certain of their assets relating to their Business of researching, developing, manufacturing, marketing, distributing, exporting and selling the Products which are marketed under the Murex Trademarks to Buyers;

WHEREAS, Sellers have adopted, used and have not intentionally abandoned the Murex Trademarks in connection with the Products, and have agreed to assign to Buyers all of Sellers' right, title and interest in and to the Murex Trademarks and the goodwill of the Business symbolized by the Murex Trademarks; and

WHEREAS, the Assignor has delivered this instrument signed by the Assignor to enable the Assignee to file it with any appropriate Governmental Authority to indicate ownership of the Murex Trademarks and for the other purposes set forth in this instrument. This instrument supplements and is in addition to all other rights of the Assignee under the Asset Purchase Agreement and other instruments of transfer delivered in connection with the Asset Purchase Agreement.

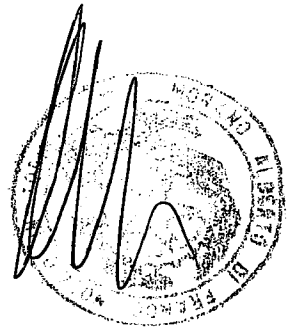
NOW, THEREFORE, in consideration of the premises set forth above and in the Asset Purchase Agreement and for other good and valuable consideration, the receipt of which is hereby acknowledged:

In consideration of One Dollar (U.S.\$1.00), the receipt of which is hereby acknowledged, the undersigned Assignor hereby sells, assigns, transfers, sets over and delivers to Assignee, Assignor's entire rights, title and interests in and to the Murex Trademarks identified on Schedule A attached hereto (including any licenses to use or any common law rights that may exist and are associated therewith), together with any common law rights of the Murex Trademarks throughout the world and together with the goodwill throughout the world of the Business symbolized by them, the same to be held and enjoyed by said Assignee, its successors, permitted assigns or legal representatives, together with income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims for damages or payments by reason of infringement or unauthorized use of such Murex Trademarks, along with the right to sue for past infringements and collect same for Assignee's sole use and enjoyment.

Assignor further authorizes any appropriate Governmental Authority of any country or countries whose duty it is to record trademark registrations, applications and title thereto, to record the applicable Murex Trademarks and title thereto as the property of the Assignee, its successors, legal representatives and assigns in accordance with the terms of this Assignment.
