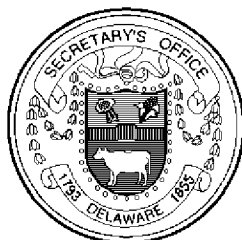

FIRST: That the shareholders and the Board of Directors of the Corporation duly adopted the following resolution on September 15, 2009:
