## TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of November 12, 2010, by PNC BANK, NATIONAL ASSOCIATION, as Grantee ("Grantee"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Assignment (as defined below).

### W I T N E S S E T H:

WHEREAS, THE RITEDOSE CORPORATION, a South Carolina corporation, formerly known as Holopack International Corp., a South Carolina corporation ("Grantor"), and Grantee are parties to a Trademark Collateral Security Agreement dated as of March 10, 2009 (as amended, restated, supplemented or otherwise modified from time to time, the "Assignment"), pursuant to which Grantor granted a security interest to Grantee in certain trademarks ("Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Grantee, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on March 10, 2009, at Reel 3949, Frame 0495; and

WHEREAS, Grantor has requested that Grantee release its security interest in the Trademarks and Trademark Rights.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:
