RELEASE OF SECURITY INTERESTS IN TRADEMARKS

ROCKIES TRADEMARKS, INC.

This RELEASE OF SECURITY INTERESTS IN TRADEMARKS is executed as of November 15, 2010 by BANK OF AMERICA, N.A., for itself and in its capacity as successor by merger to Fleet National Bank, N.A. (formerly known as Bank Boston, N.A.), individually and as administrative agent (the "Administrative Agent"). Any capitalized term not otherwise defined herein shall have the meaning ascribed to it in the Trademark Assignment (as defined below).

WHEREAS, ROCKIES TRADEMARKS, INC. (the "Company"), entered into that certain Amended and Restated Trademark Collateral Security and Pledge Agreement, dated as of December 18, 2003 (as amended, the "Trademark Assignment") with the Administrative Agent, as amended by the Second Amended and Restated Trademark Collateral and Pledge Agreement, dated as of June 23, 2005;

WHEREAS, pursuant to the Trademark Assignment, the Company granted to the Administrative Agent, as security for the Obligations, a continuing security interest in all of the Company's right, title and interest in and to certain trademarks;

WHEREAS, certain other security interests in trademarks were recorded in the Trademark Division of the United States Patent and Trademark Office on (a) February 6, 2003, at Reel 002769 and Frame 0664 and (b) January 7, 2004, at Reel 002774 and Frame 0527; and

WHEREAS, the Company has requested that the Administrative Agent release the liens and security interests granted to the Administrative Agent by the Company with respect to the trademarks listed on Exhibit A attached hereto (the "Released Trademarks").

For good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby:

(a) releases the liens and security interests granted by the Company to the Administrative Agent pursuant to any security agreement (including but not limited to the Trademark Assignment) in and to the Released Trademarks; and

(b) to the extent the Administrative Agent shall be deemed to have any right, title or interest in the Released Trademarks, retransfers and reassigns, without representation, warranty or recourse, to the Company all of such right, title and interest solely with respect to the Released Trademarks.

This Release of Security Interests in Trademarks shall be governed by the laws of the State of New York.
