## TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of November 11, 2010, and made by **WELLS FARGO CAPITAL FINANCE, INC.**, a California corporation formerly known as Wells Fargo Foothill, Inc., having an office at 2450 Colorado Avenue, Suite 3000 West, Santa Monica, CA 90404 ("Grantee") to **GORDON BIERSCHE BREWERY RESTAURANT GROUP, INC.**, a Tennessee corporation ("Grantor"), with its chief executive office at 2001A Riverside Drive, Suite 3100, Chattanooga, TN 37406.

**WHEREAS**, pursuant to that certain (i) Trademark Security Agreement dated November 15, 2006, made by Grantor in favor of Grantee (the "November Security Agreement") and (ii) Amended and Restated Trademark Security Agreement dated as of December 13, 2007, made by Grantor in favor of Grantee (the "December Security Agreement") and together with the November Security Agreement, the "Security Agreements"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

**WHEREAS**, the November Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 15, 2006, at Reel 003428 and Frame 0780 and the December Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on December 14, 2007, at Reel 003678 and Frame 0776; and

**WHEREAS**, Grantee now desires to terminate and release the Security Agreements;


**NOW, THEREFORE**, for good and valuable consideration, Grantee hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.
2. Release of Security Interest. Grantee hereby terminates the Security Agreements and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
