## TERMINATION AND RELEASE OF TRADEMARK SECURITY INTERESTS

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY INTERESTS** (this "Termination"), is dated as of November 4, 2010, and made by **WELLS FARGO CAPITAL FINANCE, INC.**, a California corporation, formerly known as Wells Fargo Foothill, Inc. and assignee of those certain security interests of Ableco Finance LLC, having an office at 2450 Colorado Avenue, Suite 3000 West, Santa Monica, CA 90404 ("Assignee") to **BIG RIVER BREWERIES, INC.**, a Tennessee corporation (also sometimes known as Big River Grille & Brewing Works, Ragtime Tavern Seafood & Grill, A1A Ale Works, Rock Bottom Restaurant & Brewery and Seven Bridges Grille & Brewery) ("Owner"), with its chief executive office at 2001A Riverside Drive, Suite 3100, Chattanooga, TN 37406.

**WHEREAS**, Ableco Finance LLC assigned certain security interests (the "Interests") in certain collateral, including the Trademarks (as hereinafter defined), to Assignee;

**WHEREAS**, such assignments were recorded in the Trademark Division of the United States Patent and Trademark Office on December 7, 2006, at Reel 003440 and Frame 0990; and

**WHEREAS**, inasmuch as Assignee no longer owns such rights in interest, Assignee now desires to terminate and release its interests in such assignments;


**NOW, THEREFORE**, for good and valuable consideration, Assignee hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Assignee's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.
2. Release of Security Interest. Assignee hereby terminates its Interests and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Assignee in the Trademarks.


