ASSIGNMENT OF TRADEMARKS

WHEREAS, Assignor wishes to assign the Marks together with all of the goodwill associated with the Marks to Assignee;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign, grant and convey to Assignee all right, title and interest in the Marks, all issued registrations or pending applications with respect to same, the goodwill of the business symbolized by the Marks and the right to sue for past infringement of the Marks. Assignor will execute any and all documents necessary to transfer ownership, title and registration of the Marks to Assignee.
