AMENDED AND RESTATED
GRANT OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

WHEREAS, LANAIR PRODUCTS, LLC, a Delaware limited liability company ("**Lanair Grantor**") owns the trademarks, trademark registrations, trademark applications, and any and all goodwill associated therewith, and the patents and patent applications, in each case set forth on Schedule A and Schedule B attached hereto;

WHEREAS, CB ACQUISITION, LLC, a Delaware limited liability company to be renamed Clean Burn LLC ("**CB Grantor**" and, together with Lanair Grantor, the "**Grantors**") owns the trademarks, trademark registrations, trademark applications, and any and all goodwill associated therewith, and the patents and patent applications, in each case set forth on Schedule C and Schedule D attached hereto;

WHEREAS Lanair Grantor and ALDINE SBIC FUND, L.P., a Delaware limited partnership, are party to (i) that certain Senior Secured Subordinated Loan Agreement, dated as of October 6, 2009, between the Grantor, Lanair Holdings, LLC, a Delaware limited liability company ("**Holdings**"), and the Grantee (as amended, supplemented and otherwise modified from time to time, the "**Subordinated Loan Agreement**"), and (ii) that certain Grant of Security Interest in Trademarks and Patents, effective as of the effective date of the Subordinated Loan Agreement (the "**Prior Grant**");

WHEREAS, Lanair Grantor and the other parties thereto intend amend and restate the Subordinated Loan Agreement, such that (among other matters) ALDINE SBIC FUND, L.P., a Delaware limited partnership, in its capacity as collateral agent (in such capacity, "**Grantee**"), CFB Venture Fund, L.P. - Series V, a Delaware limited partnership, and CB Grantor are parties thereto (the "**Restatement**");

WHEREAS, Grantee desires to acquire a security interest in, and lien on, all of Grantors' right, title and interest in and to Grantors' trademarks, trademark registrations, trademark applications and any and all goodwill associated therewith and patents and patent applications; and

WHEREAS, the Grantors are willing to grant to the Grantee a security interest in and lien upon the trademarks, trademark registrations, trademark applications and any and all goodwill associated therewith and patents and patent applications described above.

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, and subject to the terms and conditions of the Subordinated Loan Agreement, the Grantors hereby grant to the Grantee a security interest in, and a lien upon, all of Grantors' right, title and interest in and to (i) the trademarks, trademark registrations, trademark applications, and any and all goodwill associated therewith (the "**Marks**") set forth on Schedule A or Schedule C attached hereto, (ii) the patents and patent applications (the "**Patents**") set forth on Schedule B or Schedule D attached hereto, in each case together with (iii) all proceeds of the Marks, (iv) all of the goodwill of the businesses with which the Marks are associated, and (v) all causes of action, past, present and future, for infringement,

misappropriation, or dilution of any of the Marks and/or Patents or unfair competition regarding the same.

This GRANT OF SECURITY INTEREST is made to secure the satisfactory performance and payment of all the obligations and liabilities of the Grantor under the Subordinated Loan Agreement and shall be effective as of the effective date of the Restatement.

This GRANT OF SECURITY INTEREST has been granted in conjunction with the security interest granted to Grantee under the Security Agreement, amended as of the effective date of the restatement, among Lanair Holdings, LLC, a Delaware limited liability company, the Grantors, Grantee and the other parties named therein (as amended, supplemented and otherwise modified from time to time, the “**Security Agreement**”). The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement and the Subordinated Loan Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this GRANT OF SECURITY INTEREST are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.
