
NOW, THEREFORE, IT IS HEREBY AGREED:

The effective date of this assignment is November 6, 2009, retroactively.

IN WITNESS WHEREOF, ASSIGNOR has caused this instrument to be executed by its duly authorized officer this 5 day of November, 2010.


